THE SEQUENTIAL ACTIVITIES BUILD ON STUDIES FROM EACH PRECEDING GRADE AND PREPARE STUDENTS FOR THEIR FUTURES AND LIFELONG LEARNING. THE PROGRAMS WERE PRESENTED BY 789 TRAINED VOLUNTEERS THIS YEAR, WHICH IS SIGNIFICANTLY LESS THAN THE NUMBER OF VOLUNTEERS IN OTHER YEARS DUE TO THE COVID-19 PANDEMIC.
