THE SEQUENTIAL ACTIVITIES BUILD ON STUDIES FROM EACH PRECEDING GRADE AND PREPARE STUDENTS FOR THEIR FUTURES AND LIFELONG LEARNING. THE PROGRAMS WERE PRESENTED BY 2,459 TRAINED VOLUNTEERS THIS YEAR.

IN 2022-23 JANI BEGAN A NEW HIGH SCHOOL PROGRAM CALLED 3DE™ IN TWO OF THE LOCAL HIGH SCHOOLS. IN 3DE, THE LEARNING EXPERIENCE IS RE-ENGINEERED TO BE AUTHENTICALLY CONNECTED TO THE WORLD THAT EXISTS BEYOND THE CLASSROOM WALLS. (CONTINUED ON SCH O)
