## Junior Achievement of Northern Indiana 2023 Wine & Beer Festival Pappy Van Winkle 23 Year Old Raffle Rules:

1. Tickets may be purchased via cash, check or debit card. Credit card purchases are not permitted under Indiana Charity Gaming Laws.



- 2. Entrants must be 21 years of age or older.
- 3. The winner will be asked to sign an affidavit that he/she complies with the minimum age requirements and that the winner purchased the winning ticket via an approved purchase method.
- 4. Entrants to this raffle do so of their own initiative and are responsible for compliance with the entrant's own state and local laws.
- 5. Winner need not be present at the time of the drawing to win.
- 6. This raffle is a fundraising effort of Junior Achievement of Northern Indiana (JANI), an Indiana nonprofit corporation as designated by the Internal Revenue Service as meeting the qualifications of Section 501(c) (3) of the Internal Revenue Code. JANI is located in Fort Wayne, Indiana and this raffle being conducted under the laws of the State of Indiana. All proceeds will support the financial literacy, work readiness and entrepreneurial programs at JANI.
- 7. Due to postal regulations, raffle ticket stubs cannot be returned by mail if purchased through the mail or over the phone. When the order is placed, JANI will complete the ticket with the information provided by entrant and the ticket will be placed in the raffle drawing at JANI. If requested, JANI will email a photo of the completed ticket along with purchaser's ticket numbers within a week of receiving payment. - 8. The winner is responsible for all local, state and federal taxes. The winner understands, acknowledges, and agrees that the winner is receiving a prize and will hereby release and discharge JANI, and any additional sponsors, their employees, agents, officers, directors and legal representatives and assigns from any and all claims, liabilities, damages, losses or expenses arising from or caused by the award of such prize, including, but not limited to the payment of any and all taxes that are due.
- 9. In the event the bourbon is lost, damaged, stolen, destroyed or otherwise not available prior to the raffle drawing, JANI's liability to a participant shall be limited to the refund of ticket price to such participant.
- 10. The Internal Revenue Service (IRS) has taken the position that amounts paid for chances in raffles, lotteries, or similar drawings for valuable prizes are not gifts and consequently do not qualify as deductible charitable contributions.

- 11. The winner will be announced at the official drawing to be held on July 28, 2023 at 8:00 pm at the Junior Achievement Wine & Beer Festival at Parkview Field in downtown Fort Wayne, IN.
- 12. If the winner is not present he/she will be notified via phone, certified mail or email within 7 days of the drawing. The prize must be claimed within 30 days of the drawing. If the winner declines to take the prize or the prize goes unclaimed, another winner will not be selected and JANI will retain ownership of the bourbon.

- 17. Ticket sales will end at 5 pm on July 28, 2023 via phone, online, and mail. In person ticket sales will end at the event by 8 pm on July 28, 2023.
- 18. By entering this raffle, each participant releases JANI, its directors, officers, employees, and agents from any and all liability for injuries, losses, or damages of any kind caused by participating in the raffle or winning any prize or resulting from acceptance, possession, use or misuse of any prize, and each winner agrees to indemnify and hold JANI harmless from any and all losses, damages, rights, claims, and actions of any kind rising in connection with or as a result of participating in the raffle or the winner's acceptance or use of any prize.
