JA IN-SCHOOL PROGRAMS: THE IN-SCHOOL PROGRAMS INCLUDE 17 SEQUENTIAL THEMES FOR PRE-K THROUGH 12TH GRADE. STUDENTS LEARN CONCEPTS OF FINANCIAL LITERACY, WORKFORCE READINESS AND ENTREPRENEURSHIP. THE SEQUENTIAL ACTIVITIES BUILD ON STUDIES FROM EACH PRECEDING GRADE AND PREPARE STUDENTS FOR THEIR FUTURES AND LIFELONG LEARNING. THE PROGRAMS WERE PRESENTED BY 2,032 TRAINED VOLUNTEERS THIS YEAR, WHICH IS SIGNIFICANTLY LESS THAN THE NUMBER OF VOLUNTEERS IN OTHER YEARS DUE TO THE COVID-19 PANDEMIC. JA JOBS PARK IS A NEW CAREER AND WORKFORCE READY PROGRAM THAT CONNECTS AREA STUDENTS TO BUSINESSES AND ORGANIZATIONS TO "SPARK" THEIR INTEREST IN CAREERS. IT PROVIDES THE OPPORTUNITY FOR STUDENTS TO LEARN ABOUT THE SKILLS, EDUCATION, AND TRAINING NEEDED TO ACHIEVE THEIR CAREER GOALS.

AT THE CULMINATION OF THIS PROGRAM, STUDENTS VISIT LINCOLN FINANCE PARK TO PUT INTO PRACTICE WHAT THEY HAVE LEARNED ABOUT PRINCIPLES OF BUDGETING. ASSISTED BY THEIR TEACHERS AND A STAFF OF TRAINED VOLUNTEERS, THEY HAVE THE OPPORTUNITY TO DEVELOP A PERSONAL BUDGET.
